Appointed as Director of the Office of Professional Responsibility by IRS Commissioner Doug Shulman on April 13, 2009, Karen is responsible for the oversight of all Professionals practicing before the Internal Revenue Service pursuant to Treasury Circular 230 (Title 31, sec 330 et seq.), including Enrolled Agents, Enrolled Retirement Plan Agents, Appraisers, Actuaries, Certified Public Accountants and Attorneys. Prior to her appointment with OPR, she spent 25 years in private practice with Taggart & Hawkins, P.C. in Oakland, CA and was an active member of the California Bar for 30 years. Ms.

Hawkins is the founder of the San Francisco Pro Se/Pro Bono Tax Court project, which provides *pro bono* legal assistance at Tax Court calendar calls for pro se taxpayers and has served as a model for similar programs in other cities.
